Contestants must:

1. Be residents of Franklin County since July 1, 2016 and/or be enrolled in a city, county or independent school in Franklin County.
2. Be 5, 6, or 7 years of age as of June 30, 2017. A copy of birth certificate must be included with application.
3. **Appear in casual wear and a dress suitable for church. NO STRAPLESS DRESSES, NO SEQUIN DRESSES, NO PAGEANT DRESSES – NO DENIM.**
4. Participate in a personal interview.
5. Any contestant who has competed at the professional level will be considered ineligible for this pageant. Professionalism is defined as “any contestant who has performed or competed for monetary gain in anything other than amateur contest.”
6. Appropriate prizes will be given to the winner. Runners-up will be chosen. The winner will **NOT** advance to a State competition.
7. Must agree to participate in assigned Fair activities, and ride on the Fair Board’s float in the Christmas Parade in December.
8. Recognize that the judges’ decision is final. Judging will be based on appearance, poise, personality and interview. Judges will not be from Franklin County.
9. The Franklin County Fair Board and its agents cannot be held responsible for accidents, injury or loss of personal property relating to this event.
10. Harassment of fair and pageant officials/volunteers will not be tolerated. Parental interference during rehearsal and/or the pageant could be cause for participants to be dismissed. Entry fee will not be refunded.
11. Please mail completed entry form, along with a) \$40 non-refundable entry fee, and b) a photocopy of birth certificate to: **Franklin Co. Fair, Princess Pageant, P.O. Box 4565, Frankfort, KY 40604** by **July 10.**
12. A required photo session will be held at the Franklin County Extension Office on Monday, July 10 at 6:00 p.m. Photos may not be submitted.
13. A rehearsal for the contestants will be held Monday, July 17 at 6:00 p.m. at the Hancock Pavilion.
14. Contestant interviews will take place at the Franklin County Extension Office on the day of the pageant.
